Position: IAC Research Fellow

India Accountability Center (IAC) is looking for sharp, public-spirited and self-driven persons to join its team as **Research Fellow**. The ideal candidate will have a keen interest in public policy, issues related to govt. accountability; and a firm grip on the latest tech-tools.

IAC (<u>https://indiaaccountabilitycenter.org/</u>) is an initiative aimed at strengthening Indian democracy by holding the institutions and individuals in power accountable for the promises they make to the public. IAC endeavors to discover, track, and publish these promises along with their status, and also seeks to leverage the judicial process, if required, to ensure their fulfillment.

Position Summary, and Key Responsibilities:

As an IAC Research Fellow, your role will be to search, track, categorize, and analyze the promises made by the Governments (Centre as well as State), Ministers, MPs, MLAs etc. to the public, and assess their implementation status.

The spectrum of your work can broadly be divided in two time-zones:

- 1. The zone where promises have already been made in the past, and
- 2. The zone where new promises are being made in the present, and will be made in the days to come.

Your key responsibilities for the first zone are:

- 1. Dig out speeches, interviews, and public statements floating on the Internet (Google, YouTube, Twitter, Facebook, Instagram, News websites, etc.) made by various ministers in the Centre or State Govts., MPs, MLAs etc. and document the promises found in this process in our database.
- 2. Gather data from official documents, policy briefs, press releases, and other public sources.
- 3. Summarize these promises in simple language.
- 4. Tracking the progress of these promises over time.
- 5. Analyze the feasibility, progress, and impact of the promises.
- 6. Prepare reports / summaries on the status of promises, highlighting achievements and shortcomings.

And your key responsibilities for the second zone are:

- 1. Scan the Social Media profile (Twitter, Youtube, Facebook, Instagram etc.) of Prominent Ministers, Govt. Bodies, Political Parties, Media houses, etc. <u>on a daily basis</u> and document the promises found in this process in IAC's database.
- 2. Scan the prominent newspapers (English, Hindi, and any other Indian language) <u>on a daily basis</u> and document the promises found in this process in IAC's database.

The fellow will also work on a <u>weekly/ monthly Newsletter</u> which will help IAC give value to its target audience & build rapport with them. (Of course, the responsibilities listed above are only indicative and not exhaustive in nature.)

Qualifications: A Bachelor's or Master's degree in Public Policy, Political Science, Journalism, Law or a related field.

Experience: Previous experience in research, public policy analysis, Journalism, Law or a related area will be a plus.
